Candidate Nathan Groenewold seeks ordination via Church Order Article 12c:

c. A minister of the Word may also serve the church in other work which relates directly to the calling of a minister, but only after the calling church has demonstrated to the satisfaction of classis, with the concurring advice of the synodical deputies, that said work is consistent with the calling of a minister of the Word.

The following requirements are stated in the Supplement to Article 12c:

The calling church shall secure the prior approval of classis, with the concurring advice of the synodical deputies, for each new ministerial position, by providing classis with the following information:

- 1) The description of the official position (purposes, duties, qualifications, etc.) as determined by the calling church in consultation with cooperating agencies as applicable.
- 2) The evidence that the minister will be directly accountable to the calling church, including an outline of requirements for reporting to the calling church, and supervision by the calling church, in consultation with cooperating agencies as applicable.
- 3) The demonstration that the position will be consistent with the calling as a minister of the Word.

Immediately prior to Nathan Groenewold's examination, Classis must therefore vote to approve the position to which Ann Arbor CRC has called him. The description for his position is provided below.

Cohort Director Position Description

Vision — Oversight of both the vision and day-to-day implementation of the Cohort Detroit ministry, a justice-oriented ministry of immersive discipleship and Christian leadership development in Detroit. Cohort Detroit builds on existing Resonate Global Mission partnerships to meet a deep need for developing Christian young adult leaders in the Detroit context.

Position — The Cohort Detroit Director/Ann Arbor CRC Associate Pastor is responsible to:

- Create and implement discipleship and Christian leadership development curriculum for young adults serving in Cohort Detroit: weekly spiritual formation, mentoring, local partner site visits, weekly Cohort gatherings, and educational travel trips
- Mentor and guide Cohort Detroit participants and local young adults impacted by the Cohort Detroit program.
- Preach and/or lead adult education bi-monthly at area churches
- Serve as a mission network developer, building meaningful bridges between regional churches and mission partnerships in Detroit.
- Support events and training designed to deepen spiritual friendships between Ann Arbor CRC members and Detroit partners and individuals
- Raise mission support and recruiting participants for Cohort Detroit alongside the Cohort Detroit advisory council.
- In partnership with the Cohort Detroit advisory council, oversee the long-term growth, sustainability, and vision for the Cohort Detroit ministry.

Oversight — In accordance with the attached letter of call, the Ann Arbor CRC will hold the Associate Pastor/Cohort Director's ministerial credentials and take the responsibility of supervising and giving accountability for life, ministry, and doctrine. In this partnership our hope is that we might aide Nathan in flourishing in the ministry that Nathan has been so clearly gifted and called by God to do. The Ann Arbor Christian Reformed Church confirms that supervision for day-to-day ministry, as well as financial support of the ministry, will be provided by the Council of Advisors of Cohort Detroit. AACRC will not be providing any health benefits, retirement benefits, payroll, or payroll taxes.



GUIDELINES FOR CLASSIS LAKE ERIE STUDENT FUNDING REQUESTS (Feb. 2020 draft)

- Applications for funding will be submitted by August 1 for the following academic year.
- All applicants must be a member in good standing of a congregation in Classis Lake Erie.
- The criteria for evaluating applications will be (in this order) giftedness and calling, financial need, commitment to future ministry in the CRC, and connection to Classis Lake Erie.
- Funding recommendations will be capped at 50% of the student's expenses.
- Recommendations from the Leadership Development (Student Funding)
 Committee will be submitted to Classis at its fall meeting.
- Applications for funding that are received after the August 1 deadline will be
 considered *only if* there are additional funds remaining in the Classis budget, and
 will be viewed as "interim funding" until application has been received in the
 regular application cycle.
- Interim funding recommendations will be submitted to the Classis Executive Committee at the discretion of the Leadership Development (Student Funding) Committee.
