With that in view, candidates for ministry are being told not to expect to receive a call any time soon, not to expect to receive a call to full-time ministry, and not to expect to be in ministry until retirement age.

Responses to Credentials Questions

Dearborn Christian Fellowship

Discussion: How to reach millennials?

Assistance: Support in the process of Brad Stolman becoming a Commissioned Pastor in our

congregation.

Olentangy Church (Columbus)

Discussion/ Olentangy Church wishes to inform classis that the congregation has approved

Assistance: the sale of church properties and the sale contract has been signed. (The buyer is

currently in the process of exercising due diligence.) That being the case, Olentangy Church seeks advice from the New Church Development Committee regarding

relocation and restarting of its ministry.

East Side (Cleveland)

Five new members were added by "Welcoming." Three children were baptized after receiving several weeks of instruction about baptism and communion in our Young Lights for Christ program.

In June we had the privilege of hosting the memorial service for George Vander Weit. The service was conducted by George's son Randy, now an RCA minister in Muskegon,MI. It was a good time of reunion, and gave closure to the family.

On the fourth Sunday of each month we have a celebration of all the birthdays for that month after the worship service; this has been well received and gives additional time for fellowship.

Effective evangelism continues to be a challenge. The Tuesday evening Bible Study and our Women's Bible Study continue to include some attendees from the community, and some are also attending Sunday worship services quite regularly. The GEMS girls club is composed mostly of girls from the community, but fewer girls are attending the last few years; conflicting activities, transportation, homework ,etc.

We attempted an evening VBS this summer. There were few volunteers but enthusiastic! Poor response from the community. We hope to try again with some changes; we hope to use the same materials again which really presented God's plan for salvation.

We continue to provide basketball hoops and a playground area for use by the community and they are well used, but there has been some vandalism of the equipment.

Plans are in the works for a summer feeding program to start in 2017.
